## 1. License

1. The licensee orders from Partners Software the license to use and access code to the LOW.FARE UK system (here after “system”):

LOW.FAREcounter (contract code LFCSUK2)

LOW.FAREonline (contract code LFOSUK2)

## 2. License scope

1. The use of the LOW.FARE Counter UK system is limited to the licensee, and limited to one location/office.
2. The use of the LOW.FARE Online UK system is limited to the domain: \_\_\_\_\_ (please fill in the domain)
3. The use of the system by other parties than the licensee is not allowed. Partners Software reserves the right to terminate access to the system in case of mis-use by the licensee.

## 3. Support and Training

Partners Software does not provide training for the system. Support is provided on an email basis only.

## 4. Contract beginning, duration and end.

1. This contract is valid as of \_\_\_\_\_ and ends with the completion of the quarter year that follows the quarter of the contract starting date (minimum duration).
2. The validity of this contract is automatically extended by another quarter year if the contract is not terminated in writing by either party with a period of more than two (2) months prior to the end of the current quarter year.

## 5. License cost, payment

1. The monthly license fee for the system is

This monthly fee has to be paid three months in advance.

2. LOW.FAREcounter: Fee per booking: GBP 1,95

LOW.FAREonline: Fee per Booking:

For the 1<sup>st</sup> passenger in a booking: GBP 1,95

For the 2<sup>nd</sup> passenger in a booking: GBP 1,50

For each additional passenger in a booking: GBP 0,75

This booking fee is accounted for on a quarterly basis for the three months which precede the invoice date.

3. There is a threshold of a maximum 400 transactions per booking. If this threshold is exceeded by the licensee then there is an additional charge of GBP 0,0010 per transaction.
4. For the LOW.FAREcounter UK system the licensee will pay Partners Software by bank transfer or by allowing Partners Software to charge the licensee's credit card.
5. For the LOW.FAREonline UK system Partners Software will deduct the monthly charges and booking charges from the service fee which is collected from the passengers on behalf of the licensee and send the remaining amount via bank transfer to the licensee on a quarterly basis. To avoid accounting problems with traveller credit card charge backs service charges are transferred to the licensee with a delay of eight weeks after the customer credit card has been charged.
6. The licensee authorises Partners Software to charge the passenger's credit card for the service fees which have been defined by the licensee. The credit card commission for the service fee charge to the customer credit card is paid for by the licensee. This credit card commission (currently 4,5%) is deducted from the service fees before the money is sent to the licensee. Any additional costs relating to credit card charges (e.g. charge backs or non-authorized charges) are to be paid for by the licensee.

7. The licensee has to provide Partners Software with a valid European Union VAT ID number so that German VAT (MwSt.) does not have to be charged. If the licensee does not provide a valid European Union VAT ID number then Partners Software has to charge German VAT (currently 16%).

## 6. Applicable law, court of jurisdiction, writing clause

1. This contract and the entire relationship between the licensee and Partners Software is governed by German law. The sole place of jurisdiction is Bremen, Germany.
2. Should any part of this contract be invalid or unenforceable, the remainder of the contract stays in effect. The invalid or unenforceable part of the contract shall be replaced with a clause that expresses what both parties would have intended when the contract was signed.
3. Any changes to this contract require a written agreement signed by both parties.

## How the fees are charged

The charges you desire are stored into the LOW.FAREonline system by Partners Software. As a flight is booked the appropriate air fare is charged by the airline and the fee is charged by Partners Software in a separate credit card charge. The customer receives an email from partners software, advising the customer about the service charge and for which travel agency/tour operator the charge is generated. This allows the customer to identify the service charge and understand why there are two charges to the credit card. All service charges collected are set off against the costs that arise from using LOW.FAREonline and paid out quarterly.

Partners Software will then implement the service charge into your agency profile as applied for. The first implementation of the service charge facility is free of charge. For any subsequent changes a fee of 25 EUR or 17,50 GBP will be charged to you.

\* Please remember that on some airlines (e.g. HLX) the use of the agency access will increase the flight price by e.g. EUR 7,50. Therefore it could be sensible not to use the agency access on such airlines as LOW.FAREonline will add you service fee on top of the higher airline price (until we are able to differentiate service fees by carrier).
